Consensus Input Document Discussion

- Consensus Input Document created from results of survey and input from the discussions during meetings
- Needs 85% approval from Task Force to pass
- Additional suggestions from Task Force members:

- Emphasize conservation of water
- o Highlight New Mexico's ongoing innovations while leaving room to grow
- Include waterway health and upland watershed health
- o Support clean-up of contaminated locations
- Modernize technology related to water measurement, analysis, and monitoring across all sectors
- Clearly define terminology used in report (e.g. infrastructure, beneficial use)
- Address aging infrastructure
- o Include utilization of effective tools by local agencies
- Utton Center will edit Consensus Input Document to reflect Task Force member suggestions and it will be sent out for members to vote upon before next meeting

Review of Water Task Force Workgroup Reporting Form and Process Guide

- Feedback from Task Force members:
 - o Identify how specific Task Force recommendations should be
 - o Include timeframe column to ensure timely implementation
 - Identify which agency/group will implement recommendations
- New Mexico First will update form to reflect these suggestions
- Workgroup Reporting Form will be an evolving document as Workgroups populate with recommendations
 - Workgroup members will report suggestions to Co-Leads
- Additional Notes:
 - National Conference of State Legislators (NCSL) offers information to task Force regarding how other states are creating/have created similar reports
 - Policy recommendation examples can be found in NMF Water Town Hall Report from 2014 and LFC Capital Outlay Subcommittee Report from 2022
 - Workgroups are asked to critically review their recommendations to identify potential issues and ensure intent is evident

Workgroups Present Problem Statements

- 1st Workgroup: Community, Drinking Water, Stormwater and Wastewater Capacity, Infrastructure, and Finance
 - o Identified issues:
 - Capacity is an overarching issue at all levels
 - Request for regional water model examples
 - Emergency management for natural disasters and consequences of current vulnerabilities within the systems, especially relief funding
 - Collaboration required from all partners

- Funding program processes need to be reviewed and improved upon
- Feedback from Task Force:
 - Allow for creation of water re-use opportunities
 - Tweak language to be more inclusive of larger systems
- 2nd Workgroup: Water Resources and Management
 - o Identified issues:
 - Water governance Structure, capacity, and funding of agencies
 - State & regional water planning Scientific foundation, organization, and community capacity-building
 - Balancing water use Includes all tools for demand management and flexible water use. Transactions, AWRM, shortage sharing, and supply augmentation
 - Feedback from Task Force:
 - Identify and recruit potential employees for the desired positions/tasks
 - Highlight the importance of both local capacity and equity
 - Include language to support funding for both agricultural infrastructure and local groundwater recovery
- 3rd Workgroup: River, Aquifer, and Watershed Health
 - Feedback from Task Force:
 - Begin statement with emphasis of better river/watershed management
 - Clearly define terminology
 - Include timescales for disaster recovery
 - Address issues within the topic of groundwater (transfers, recovery, etc.)
- Overlapping Topics from all Workgroups:
 - Aquifer health and demand issues
 - o Land management
 - Infrastructure (state level monitoring)
 - o Water transfers
 - Water governance both local and state level
 - o Identify gaps in Forest Action Plan and address them
 - Agricultural use needs to be addressed
 - o Time scales of projects
 - o Agency capacity
 - Food systems physical infrastructure as well as the collaboration necessary to sustain this system
